All member Federations **MUST** submit the two Intentions to Enter forms, one for the **2020 IWWF EUROPE YOUTH WATERSKI CHAMPIONSHIP** and one for the **2020 IWWF EUROPE UNDER 21 WATERSKI CHAMPIONSHIP** through the online Admin system at: http://iwwfeatc.com/ by **04-june-2020** using the password which was provided to your Federation for this purpose.

For late submission of the Intention to Enter form a penalty of **200,00€** will be applied in accordance with E&A Additional Rules 1.3a.

To be accepted, the "Intentions to Enter" forms must be accompanied by a deposit amounting to 50,00€ for each athlete mentioned on the form. (For instance: 3 athletes :3x50,00 € = 150,00 €).

Receipt number, must be entered on the form at the time of submission.

This amount is non-refundable. This 50,00 € will be deducted from the entry fee to be paid for each athlete. The Federation may enter up to two additional athletes more than originally declared on the "Intention to Enter" form. If more than two additional athletes participate, then a fee of 50,00 € per additional athlete will be levied upon that Federation.

6. OFFICIAL FAMILIARIZATION

E&A Tournament Additional Rule 1.18 (Replaces IWWF rule 1.12)

The last two days immediately before the Championships will be reserved and used for Official Familiarization. This will be organized so that each competitor who has paid shall be allocated either a set number of passes and/or a certain amount of time at the discretion of the Chief Judge based on the principle that every skier shall receive an equal opportunity for familiarization.

Slalom skiers will receive – 4 passes or 6 minutes whichever is less
Tricks skiers will receive – 2 passes or 5 minutes whichever is less
Jump skiers will receive – 3 passes or 6 minutes whichever is less

Each team requesting familiarization time shall indicate on the official Intention to Enter form, familiarization is required, which must be submitted at least 60 days before the scheduled start of the event. They must indicate how many skiers in each event wish to participate. Teams who do not comply with this deadline will not be included in the familiarization schedule.

At least 45 days before the scheduled start of the event, the Organizer (in consultation with the Chief Judge, whose decision shall be final) shall announce the official familiarization schedule (including the allowed time). Time will be scheduled for competitors on a random team basis, and shall be grouped by event, i.e. slalom familiarization, trick familiarization and jump familiarization (by jump height) will be grouped together.

Any athlete whose time has not been paid for at least 30 days before the scheduled start of the event, or who is not ready to ski in accordance with the schedule, will lose their official familiarization time.

The Chief Judge shall have the discretion to change the start time of team's familiarization based on extraordinary circumstances.

The Organizer may offer additional training during any unallocated times.

The maximum cost per hour for Official familiarization will be € 240,00 (€ 4,00 per minute).

20. HOW TO ENTER THE COUNTRY

Info provided by: Ministry of Foreign Affairs and Cooperation: http://www.maec.es/

The documentation you need will depend greatly on where you are coming from:

If you are a citizen of any nation in the European Union,

Switzerland, Norway, Iceland, or Liechtenstein, you will only need your National Identification Document or a current passport. For minors, the National Identification Document must be accompanied by written parental permission.

If you are from Andorra, Argentina, Australia, Bolivia, Brazil, Brunei, Canada, Chile, Costa Rica, Croatia, El Salvador, the United States, Guatemala, Honduras, Israel, Japan, Malaysia, Mexico, Monaco, Nicaragua, New Zealand, Panama, Paraguay, the Republic of Korea, Romania, San Marino, the Vatican, Singapore, Uruguay, or Venezuela you will need to show a valid passport to enter Spain. Your stay may not exceed 90 days.

If you are coming from any other country, in accordance with EU regulations, you must apply for a visa at the Spanish Consulate for your country. You must also show an official passport. In this case, Spanish authorities may require proof of accommodation, reservation confirmation by an official travel agency, a return ticket, tour agenda, or personal invitation. Likewise, you may be required to provide proof of sufficient funds to cover your stay in Spain.

As the conditions stated above may vary, we recommend you contact the Spanish Consulate or Embassy for your country to ensure you meet all requirements before traveling.

I am in good physical and mental health and I am physical capable of competing and participating, and fully competent to participate and compete, as a competitor in the Championships and that i have not been certified and/or advised otherwise by any qualified medical practitioner;

- 4. I acknowledge the authority of IWWF [and its member National Federations and/or National Anti-Doping Organizations] under the IWWF Anti-Doping Rules to enforce, to manage results under, and to impose sanctions in accordance with the IWWF Anti-Doping Rules.
- 5. I acknowledge and agree that any dispute arising out of a decision made pursuant to the IWWF Anti-Doping Rules, after exhaustion of the process expressly provided for in the IWWF Anti-Doping Rules, may be appealed exclusively as provided in Article [13] of the IWWF Anti-Doping Rules to an appellate body for final and binding arbitration, which in the case of International-Level Athletes is the Court of Arbitration for Sport (CAS).
- 6. I acknowledge and agree that the decisions of the arbitral appellate body referenced above shall be final and enforceable, and that I will not bring any claim, arbitration, lawsuit or litigation in any other court or tribunal.
